Photography Session Permission Form, Policy and Fees

The Stonefield Cellars Winery property is a beautiful setting for photographing people and special events. Both professional and amateur photographers appreciate our artfully landscaped gardens, vineyard, and charming farm structures as a varied backdrop for nature, people, and event subject matter. Our Barrel Room and Century Old Farmhouse interiors have been featured in many portrait sessions. We work hard at providing a welcoming and pleasing environment for our guests and professional photographers. Adherence to our Photography and Site Policies along with Portrait Photography Session permits/fees enable us to continue to do so.

Guest (patrons) Photography

Guests of Stonefield Cellars Winery are welcomed to take snapshot photos of the winery, individuals, and subjects that capture their experience during a visit to our Tasting Room or during one of our outdoor events. We ask that guests still observe our Photography and Site Policies. Guests may share their photos on their own or Stonefield Cellars Winery's social media outlets including Facebook, Twitter, and Instagram. Should any photos posted on the internet or published in print be inappropriate as defined by Stonefield Cellars Winery, Stonefield Cellars Winery will request that the photos be removed from public access.

Wedding Photographers

Photographers hired for weddings that are held at Stonefield Cellars Winery are able to take photos on the day of the wedding for no additional fee.

Photography Sessions - Scheduling and Fees

Photography Sessions require advance scheduling and payment of a site fee. Group size limitations and fees may apply depending on day/time scheduled.

Photography Session Scheduling - Photographers must complete and sign this Photography Permit Form at least one week in advance of the requested date/time. Availability is subject to other winery events that may or may not be posted on the winery website calendar.

Photography Session fees:

- Up to 10 persons (includes subjects, photographer, and photographer assistants) - \$60 per 1 hour session (minimum) during normal business days/hours, \$100 per 1 hour session (minimum) outside of normal days/hours. Sessions extended past 1 hour will be charged at the same rate as the first hour, but will be prorated to the nearest $\frac{1}{4}$ hour.
- 10-25 persons (includes photographer, photographer assistants, subjects, etc.) - \$80 per 1 hour session (minimum) during normal business days/hours, \$120 per 1 hour session (minimum) outside of normal days/hours. Sessions extended past 1 hour will be charged at the same rate as the first hour, but will be prorated to the nearest $\frac{1}{4}$ hour.
- 26+ - Consult with Stonefield Cellars Winery staff regarding sessions of this size for a quote as additional factors may impact fee amount.

Sessions must be scheduled and a \$25 deposit paid in advance. Deposits are non-refundable.

Photographers and their clients must comply with the following rules:

- Photographers must check in with Stonefield Cellars Winery staff prior to any photography session.
- Photography must not interfere with normal customer activities or scheduled events.
- No furniture or other fixture may be moved or arranged without prior permission.
- No picking or disturbing flowers, shrubs, vines, or trees.
- No disturbing animals (winery cat or chickens).
- Any interior shots (in winery building or winery house) must be supervised by Stonefield Cellars staff to ensure that only areas/views that are appropriate for public viewing are accessed. Interior shots may not always be available (check with Stonefield Cellars staff first)!
- A Stonefield Cellars staff member will accompany the photography session to help with any staging needs and to assure that rules are followed.
- All other property rules must be followed, including but not limited to no smoking, no dogs/pets, and any health and safety regulations/policies. Failure to comply with rules will result in expulsion from the property.
